



Dear Madam,

I have been asked by An Bord Pleanála to refer to the above-mentioned appeal.

The Board has examined the appeal and is of opinion that certain information is necessary for the purpose of enabling it to determine the appeal.

In accordance with section 10 of the Cocal Government (Planning and Development) Act, 1992 you are required to submit, within one month beginning on the date of this notice, the following information:

Having regard to the large volumes of solid waste residues generated by the proposed incineration process on the site, its ultimate disposal details are required. The E.I.S. does not detail the locations of waste residue disposal. These are required as are general conditions of disposal sites. An incineration process handling 150,000 tonnes/annum and generating 30,000 tonnes/annum of solid waste residues requires final destination(s) of residual residue to be detailed.

If the information required is not received before the end of the specified period, the Board will dismiss or otherwise determine the appeal without further notice to you in accordance with section 11 of the 1992 Act. Your submission in response to this notice should be received by the Board not later than 5.30 p.m. on 27th September, 2002.
