Dear Mr. Griffin,

I refer to yours of 21st October 2005, your ref. MG/mg 10'05/WMP 2002/26 and content thereof.

In your letter you accepted that material dumped and spread on lands to rear of my home at Wilkinstown was derived from waste that had been subjected to 'treatment' and was thus then defined as a 'product'. Please let me have details of the source of this waste and this 'product' and of the treatment as stated and clarity whether 'product' is classified agricultural, commercial or industrial.

While my opinion means little in the scale of your grand Waste Management Plan this product could in my opinion only be classified as a 'waste product' and could be nothing else.

No matter what treatment this waste may have been put through the 'product' remaining still consists of waste products of undetermined source, plastic/rubber products, glass, wood, metals etc. are all still evident and materially unchanged and whatever other chemical elements, paint/solvent particles that were present in original 'waste' also clearly remain in end 'product'.

As you would appear to have evidence to the contrary and have stated that product does not pose an environmental threat' I would appreciate if you would provide me with this evidence as soon as possible.

Please forward all technical documentation/test literature to support this and details of the relevant Waste Permit and Planning Permission allowing for the spreading of this 'product' including conditions relating to amounts and times of spreading, spreading areas and consequent environmental effect of spreading this 'product' along with relevant documentation/EIS detailing the effect or non effect this 'product' has on the flora, fauna and human habitation in this area.

As I understand that as all 'products' have to achieve an EC standard and be proven safe in application and use your evidence of this with regard to this 'product' would also be appreciated.

I am very concerned that the fields around my home are being used for the disposal of an untested 'waste product' and I do not want my present of future family's health put in jeopardy as a result of Meath County Council and Private Enterprise treating area surrounding my home as an open landfill waste site by allowing this to continue.

The dumping and spreading of this 'product' on agricultural lands is not sustainable and it is in my opinion merely a veiled thinly spread disposal of waste where entire countryside is considered as one large open dump. How many tons of waste per acre do you intend to permit and how many tons per acre can the countryside accommodate before it is entirely contaminated and incapable of supporting crops, wildlife and human habitation.

This must stop Please address this matter by prohibiting all further 'dumping and spreading of this product in this or any other area.



I understand from further phone call at that time that you had an inspector visit lands and report and that he saw no activity at time of his visit.

I requested that you contact company and find out what was being spread on these lands, what was the source and if there was a permit/licence/permission for production, transportation and spreading of this waste. There not as yet received this information.

All these activities require documentation under current legislation and records must be maintained and made available to **you** under this legislation.

Please contact this company and request this information and let me know if product spread on these lands has been certified as safe for spreading on agricultural lands and that there is no health risk in any way **as** a result of this activity. I have a shallow well in my garden next to these lands that I am concerned about contamination of this and also any possible health risks from bioaerosols and heavy metals in this type of product.


