Re: **Amended Corrib Gas Terminal EIS**

The Environmental Protection Agency wrote to you on 27<sup>th</sup> September, 2006 enclosing an Addendum to the Corrib Gas Terminal EIS (Environmental Impact Statement).

Essential information, regarding cold venting of gas, was left out of the original EIS sent to you (and other Notifiable Bodies) for planning permission. This was a breach of the EU EIA Directive since this EIS was the fundamental basis of decision-making for all the State Planning and Protective Agencies. Planning Permission was granted by Mayo Co. Co based on this information

Subsequently, after bypassing in this way the essential planning permission to cold-vent gas, Shell E & P Ireland Ltd has applied most irregularly to the EPA for this permission. Your responsibility is to ensure that this is not allowed to go unchallenged as this is a SEVESO site and the cold-venting of gas is a health and safety issue which must be determined under Planning legislation which is the sole prerogative of Mayo Co. Co.
