


I refer further to the above-mentioned proposed development which is the subject of a current application to the Board for approval under section 226 of the Planning and Development Act, 2000

Photographs indicating the existing situation and photomontages indicating the views with the development in place should be prepared and submitted for viewpoints 7,17,18,28,29,32,33 and 36 (as indicated in appendix no.6.1) using a focal length of 70mm.


