## RE: AMENDED CORRIB GAS TERMINAL ENVIRONMENTAL IMPACT STATEMENT

Dear Mrs Moran

Further to your e-mail of 19th October 2006, I wish to make the following points:

The information contained in the addendum to the Environmental Impact Statement that you refer to was, as I understand, formally requested by the Environmental Protection Agency on 11th August 2006 to allow it to evaluate Shell Experience's application for an Integration Pollution Prevention Control Licence.

The Environmental Protection Agency are obliged to have regard to the Environmental Impact Statement and any further information relating to the Environmental Impact Statement that the Environmental Protection Agency formally request by way of a notice to the Integration Pollution Prevention Control Licence applicant.

Following the appeal of the Council's decision on P03/3343 for the Gas Terminal to An Bord Pleanála the Council has no legal power to revisit the planning application. The only function the Council now has is to monitor and ensure the implementation of An Bord Pleanála's conditions.

Given the above and the fact that the information was requested by the Environmental Protection Agency as part of the Integration Pollution Prevention Control Licence application it is more appropriate that your concerns should be addressed directly to the Environmental Protection Agency.

I hope this clarifies the Council's position for you.
