Dear Madame,

In response to your letter dated 11 January 2007 regarding the licence review of the Kepak facility in Clonee, Co. Meath, Fingal, County Council would like to submit the following points for consideration.

A review of sampling results 2005 & 2006 highlighted the following. Over this two year period, a 24 hour composite sample as dictated by the monitoring schedule was unattainable from the Kepak premises. With no alternative Grab samples had to be taken. The problem was reported but continued until July 2006. Failure to supply composite samples for an 18 month period constitutes a non-compliance with the existing Fingal County Council consent to discharge to sewer.

The existing IPC licence lists only 3 emission limit values for Kepak effluent grab samples – BOD (3,000 mg/l), COD (6,000 mg/l) and SS (1,500 mg/l). Therefore compliance of these samples can only be assessed against these parameters. In summary, 10 grab samples were received in 2005 and 6 grab sample samples and 5 composite samples were received in 2006.

Non compliances for grab samples are highlighted in the attached table. These show non compliances with BOD, COD and SS on 15/06/2005, SS on 21/12/2005, COD and SS on 29/03/2006 and COD and SS on 16/06/06. These represent four dates of the 21 sampled.
