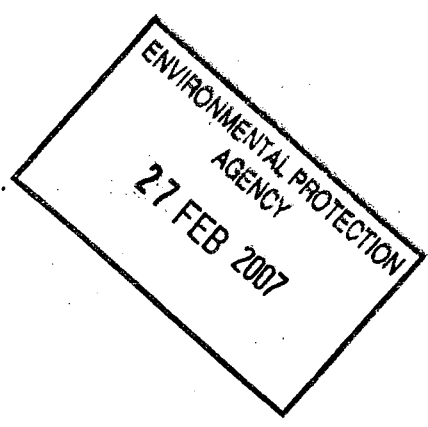

The only way I can describe this obnoxious odour is stand beside a slurry pit and inhale. This is what the people in this area have to suffer.


Several complaints have been made to Kildare County Council, and I have complained to your E.P.A office but to date there has been no result.

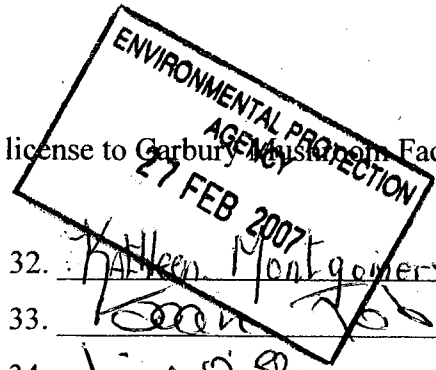
