

The notice should state that the further information contains additional data relating to
 - the likely effects on the environment of the proposed development, and

the likely consequences for proper planning and sustainable development in the area in which it is proposed to situate the said development of such development,

and that the additional information relates to the following document/CD's.

- (a) Document entitled "Traffic Noise Impact Assessment" and the two CD's entitled "Visualisation of the Dublin Waste to Energy Facility" and 'selected materials from the public domain Dublin Waste to Energy Project'.
- (b) The notice should also state that the two CD's were previously available for inspection by the public with the EIS during the period for public inspection.

The notice should further state the document submitted which is referred as appendix 9.3 in the EIS is deemed by the Board to contain significant additional data relating to the likely effects of the development on the environment and on the proper planning and sustainable development of the area.

The notice should also state that the further information will be available for inspection or purchase at a specified place and at specified times during a specified period which shall be not less than 3 weeks, and that submissions and observations in relation to the further information may be made in writing to the Board before the expiration of the indicated period.

(2) Send notice of the furnishing to the Board of significant additional information, and a copy of the additional information, to the bodies and persons referred to in subsection (4)(b) and the authority (where appropriate) referred to in subsection (6)(b) of section 175 of the Planning and Development Act, 2000 and to indicate to such bodies and persons and the authority (where appropriate) that submissions or observations in relation to the additional information may be made in writing to the Board before a specified date.

In respect of (1) above the notices should be published in the same newspapers in which notices of the original application were advertised and the additional information should be made available for inspection or purchase at the same locations at which the original application documentation was available. In respect of the time limits for the making of submissions or observations in relation to the additional information to the Board under (1) and (2) above please indicate the specified time limit for the receipt of submissions to be not later than 5.30p.m. on a single specified day.

A copy of the relevant newspaper notice(s) and the copies of notices issued to prescribed bodies should be forwarded to the Board as soon as possible.
