The recycling facility for Green Waste in Esker Lane in Lucan is the largest Green Waste Recycling facility in Ireland.

On behalf of the A.L.C.I, we would request that the facility at **Esker Lane in Lucan be kept open to landscape contractors** until a meeting can be arranged with ourselves and the Irish Gardeners and Landscapers Organisation (I.G.L.O.).

As representatives of the primary producers of recycleable Green Waste, we feel that it is appropriate that we be involved in any decisions on this issue.

We will be available to meet with South Dublin County Council at any time.
