We are putting in a submission re the above. The hours that Panda Waste is operating at the moment are as follows:

Trucks start leaving and entering facility from 4.30am right through to 8.00pm, after this time it eases with a few trucks entering up to 11.00pm Monday – Friday. On Saturday's from 5.30am – 6pm. Sunday's trucks enter and leave at various times. During these times there are machines operating in yard i.e. Trommell etc including Sunday's and Bank Holidays. This violates there EPA license conditions (see attached).

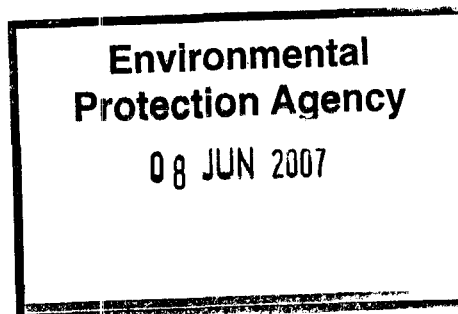
There is still an odour problem despite complaints being made to Panda Waste and to Ann Pearson of the EPA in the past.

Part II Conditions

Condition 1. Scope

- 1.1 The facility shall be controlled, operated, and maintained and emissions shall take place as set out in this licence. All programmes required to be carried out under the terms of this licence, become part of this licence.
- 1.2 Waste activities at the facility shall be restricted to those outlined in the licence review application and listed and described in Part I: Activities Licensed and authorised by this licence subject to the conditions of this licence.
- 1.3 Only those waste categories and quantities listed in *Schedule A: Limitations*, of this licence, shall be accepted at the facility. With the exception of household hazardous wastes delivered to the Civic Amenity Facility, no hazardous wastes or liquid wastes shall be accepted at the facility.
- 1.4 **Waste Acceptance Hours and Hours of Operation**
- 1.4.1 Waste shall be accepted at the commercial transfer element of the facility only between the hours of 0800 and 1830 Monday to Friday inclusive and 0900 to 1400 on Saturdays.
- 1.4.2 Waste can be accepted at the Civic Amenity element of the facility only between the hours of 0800 and 1830hrs Monday to Friday inclusive and 0900 to 1600hrs on Saturdays.
- 1.4.3 With the exception of automated composting operations, or as may be necessary in an emergency, the facility shall be operated only during the hours of 0730 and 1900hrs Monday to Friday inclusive and 0830 and 1700hrs on Saturdays.
- 1.4.4 Waste shall not be accepted at the facility on Sundays or on Bank Holidays.
- 1.5 For the purposes of this licence, the facility is the area of land outlined in blue on Drawing No. 1.4 of the application. Any reference in this licence to "facility" shall mean the area thus outlined in blue.
- 1.6 No alteration to, or reconstruction in respect of, the activity or any part thereof which would, or is likely to, result in
- (a) a material change or increase in:
- The nature or quantity of any emission,
 - The abatement/treatment or recovery systems,
 - The range of processes to be carried out,
 - The fuels, raw materials, intermediates, products or wastes generated, or
- (b) any changes in:
- Site management infrastructure or control with adverse environmental significance,
- shall be carried out or commenced without prior notice to, and without the prior written agreement of, the Agency.
- 1.7 This licence is for the purposes of waste licensing under the Waste Management Acts, 1996 to 2003 only and nothing in this licence shall be construed as negating the licensee's statutory obligations or requirements under any other enactments or regulations.
- 1.8 This licence is being granted in substitution for the waste licence granted to the licensee on 31st July 2002 and bearing Waste Licence Register No: 140-1. The previous waste licence (Register No: 140-1) is superseded by this licence.
