

Submission

- Ten existing houses and planning for two more dwellings less than 1.25KM from the proposed site for the sludge hub, with one dwelling 0.68Km from the proposed site.

Cuilmore primary school is less than 2.5Km from proposed sludge hub site, there are three other schools in the catchment area- Glenisland National School, Leitir National School and Fahy National school.

- The odour – this is an existing problem in the area already which will increase with the instalment of a “Sludge Hub”
- Noise Pollution- Machinery operating at site will impact on the surrounding area day and night.
- Dust- as a by-product of processing this is prone to possible explosions. A large amount of fuel (Diesel, Gas) will be stored on the site. This will also impact wildlife and farming in the area.
- Devaluation of housing and lands in the area due to the close proximity of the “Sludge hub”- this is not mentioned in the Tobin Environmental impact statement.
- Infrastructure- existing road not good enough to cope with the existing traffic not to mention the forecasts of increased traffic cited in the Tobin report.
- Pollution- Impact on Lough Beltra- Bio solids is a more palatable name for sewage sludge. Generally, these bio solids contain decomposed or partially decomposed organics, salts, non reactive matter such as grit and soil human pathogens and heavy metals. Heavy metals or RCRA (Resource Conservation and Recovery Act) metals include Arsenic, Cadmium, Lead and Mercury. Bio Solids also contain bacteria, viruses and parasites. Along with the nutrients, Bio solids carry heavy metals and pathogens into the soil and surface waters (lakes, rivers and streams) and the ground water. These metals and pathogens can accumulate and prove to be a risk to humans and animals.
- Eyesore- the “Sludge hub” will create a negative visual impact due to its elevated position beside the main R311 which is a significant tourist route .


