Corrib Onshore Pipeline - Invitation to RPS Open Day, 12th June, 2007.

Dear Tadgh,

RPS Group have been appointed by the Corrib Gas Partners, to identify an alternative route for the Corrib onshore pipeline. Our brief includes examining alternative route options as well as undertaking work around environmental, technical, planning and consultation activities. Clearly consultation with landowners, local residents, the wider community, and the relevant statutory bodies will play an important role in finding a new route.

As you may be aware the recommendation in the Peter Cassells report that the Corrib Gas Partners have agreed to implement, states that the pipeline should be modified within the vicinity of Rossport. Over the past months we have engaged in consultation around the criteria that should be taken into consideration as we move towards selecting a route. We have spoken to members of the local community, to statutory bodies and to other interested parties.

We have also carried out initial technical and environmental work based on vantage point surveys and on existing data. We have now identified alternative route corridors within this core study area but have also looked at corridors within an extended study area. The route corridors are broad areas of land (approximately 300 metres wide) within which a pipeline could potentially be routed.

On the 12th of June in the Broadhaven Bay Hotel we will hold an Information Evening from 3pm - 9pm during which all of the route corridors and the facts and constraints involved in each will be available for discussion and comment.

We are aware that you participated recently in the EPA's Oral Hearing and would like to invite you to this Information Evening at which members of our RPS technical and environmental team will be present to answer any questions or queries you may have in relation to the re-routing of the onshore pipeline.
