Re: Application by Oxygen Environmental Ltd, for a licence to operate an integrated Waste Management Facility at Lismagratty and Corranure Townlands, Cavan, Co. Cavan. Your ref: W0248/01

I wish to make a submission against the proposed extension of the above facility on the following grounds.

- 1. The existing facility is not been managed correctly as is demonstrated by the number of times the smell is quite disgusting to me and I live 3 miles from the actual dump on the other side of town.
- 2. Furthermore my daughter and her partner live less than ¹/₄ mile from this dump and their lives are very badly affected as it is. - 5. I feel that any promises made by this company will be broken as soon as the spotlight goes off them as in the long run they are in the business of making profit and if they can save money by cutting back on necessary staff they will do so to the detriment of the local area.
- 6. I fell very strongly that Cavan Town should not be used as the dumping ground for the rubbish and filth of the North east and Dublin region.
