Current Licence: W 199-01, Srahmore Peat Deposition Site located in Srahmore and Attavally

Deposition of up to 75,000 m3 of peat from the proposed route of the Onshore Corrib gas pipeline.

Dear Sir/Madam,

I am hereby making a submission to the above application for the deposition of 75,000 m3 of peat from the proposed route of the Onshore Corrib gas pipeline, which to a great extent will be excavated and transported from Chainage 85.960 to 88.600, the land commonly known as Rossport Commonage which is jointly owned by 62 shareholder in equal shares.

I have failed to find the permission by the joint owners to allow the developer to excavated valuable peat from the jointly owned land and export it to the Srahmore peat deposition either as sold goods or waste.

I submit to you that unless Bord Na Mona has proof that the peat has been taken out of the jointly owned property and exported with the permission of the joint owners and/or with permission granted under relevant legislation, Bord Na Mona will be accepting stolen property from lands that are subject to property rights and turbary rights of owners and occupiers.

There is no evidence of a valid purchase or otherwise of this peat.

The application therefore is invalid.
