Thanks - the location of the area where the capping is to take place (i.e outside of the harbour) will still be on the foreshore, so I would still be of the view that (if anything is needed in addition to the Dumping at Sea permit) a capital dredging licence might be the best way of dealing with it and I'm saying this with a view to avoiding having a more onerous than necessary regulatory regime on the overall operation - I wouldn't see a lease as being relevant - it's not an occupation of the foreshore in the same sense as say constructing a breakwater, or building a marina - we will have a look at the Dublin Port case if we can lay our hands on it

The area proposed for the disposal of the contaminated material, to be capped with clean material lies outside the harbour area itself. The proposed site is just to the northeast of the entrance to the channel entrance and is outside the navigation channel. The HC have made a DAS application and that is what is being assessed at present. The issue of a lease for the site is not something I had thought about before but, while it is essentially an administrative / legal issue, I would welcome clarification from CZMD. Obviously it will only become an issue if the decision is made to approve the proposal.

As I recall a permit was issued a couple of years ago to Dublin Port for a similar "capping" operation so it might be helpful to review this file. I don't recall the file reference.
