With reference to notice issued by Arklow Arbour Master, published in Wicklow People 18/03/09, regarding proposed dredging operations and dumping of dredge spoil at sea. This notice is issued under the Dumping at Sea Acts 1996 to 2004, for which i believe the Minister has direct imput and control.

I wish to inform the minister and the Coastal Mamagement Division Dept of Agriculture, that a considerable amount of the material to be dredged contains untreated sewerage amongst other items, which could also include heavy metals due to ship yard and boat works within the harbour, and former mining operations up river

I am in favour of dredging operations with a view to developing an under utilised resource and to clean up the river/port area. however i am extremely concerned as to the potential environmental pollution that would most likely be caused by dumping this spoil prior to its treatment.

I do appreciate that the Minister has a large amount of responsibilities, however it would be remiss of me not to bring this matter to his and his Office's attention, prior to any potential damage which could be caused by this spoil near to a large amount of Blue Flag beaches in the height of summer.
