

To Whom it may concern:

I wish to object to the granting of the above as over the years I have had to tolerate the terrible odour which has been increasing in recent times as can be evidenced from the enclosed copy of the Anglo Celt following the stench from the Landfill last weekend which was quite intolerable. This is an on-going problem and seems to be without resolution. I have also had a dreadful problem with litter - again no resolution.

The traffic problem speaks for itself - an endless stream of trucks on a part of the road which is quite inadequate for such a volume of heavy traffic. The birds attracted by the landfill have done an endless amount of damage to property.

Recently, the raising of the level of the landfill over my holding, blocking the drain due to the subsidence with the weight of product, creating a swamp on my lands which frequently fills with leachate poisons the animals on my farm & has turned a portion of my property into a wasteland. Leachate is still creating a problem - again unresolved.

The management of the facility has to be called into question as the problems occurring when Cavan County Council were operating & prosecuted

for some have still not been resolved and
indeed have worsened.


The fact that none of the problems with the
