## Re: IPPC License Application - C & D Foods - Ref: P0908-01.

THE PARTY OF THE P

I refer to your letter, dated 11<sup>th</sup> January 2011, Ref No: \$\mathbb{P}0908-01\$, advising Longford County Council of application for IPPC license by C & D Foods Ltd.

Under the new IPPC license, Longford County Council confirms that it will allow a higher flow rate, up to 400m3/day, at a daily maximum concentration of 400mg/ltr BOD.

Please note that the existing maximum londing limit of 80 kg/day BOD still has to be adhered to.

Also note that the 16.66 m3/kour maximum flow rate is for effluent only from the C&D wastewater process. LCC understands that there will be additional cooling waters and reverse osmosis backwash, giving an additional maximum clear water discharge of 10m3/h to LCC sewer network. The effluent and clear water streams will be combined before discharge to sewer at point SEP1.

This continues the existing load limits and is acceptable to LCC with regard to the loading on our WWTP for the immediate future.

Please note that the existing and reserved loading will be subject to a review, to be conducted with C&D Ltd later this year, with regard to compliance with the relevant policy requirements, and in particular Department of the Environment Circular L4/02 (WSP) Re: Implementation of Water Services. Pricing Policy – Model Water and Waste Water Agreements and General Guidance.
