I am in receipt of your correspondence dated 01/03/2011 & 31/03/2011 affording us the opportunity to make a submission on Mr. Curran's objection.

We believe that Mr. Curran has raised a number of valid points that should be dealt with in conjunction with the points that we have made through the IPPC process.

We also have concerns regarding any alleged movement of any waste from the applicants abattoir in an unauthorised manner.

We would also like to point out that we carried out an investigation of the watercourses on 30<sup>th</sup> March last as a result of a complaint we received. On foot of this investigation we issued a warning letter to the applicant dated 31<sup>st</sup> March 2011. We also informed an inspector in the EPA Office of Environmental Enforcement about the matter. As a result we would like the EPA to ensure that appropriate interceptors are installed on all lines discharging to watercourses as soon as possible in order to protect local tributaries of the River Nanny, a salmonid river.

Please contact us again if you wish us to elaborate on any of our points and we look forward to your decision in due course.
