I refer to your referral on Future Pigs Ltd, waste permit application, Ref. P0420-03.

In relation to the information (disk) forwarded to the Council it would appear that the disk does not contain all the information submitted in the planning application, Planning Reference No. 10/0846, refers.

The Planning Authority would like the following conditions of the permission granted noted and included as part of any revised license you may decide to grant. In particular condition no. 2 restricting inputs into the bio digester and condition no. 3 restricting the guantum of input to 23,000 tonnes.

1. The development shall be carried out in accordance with the plans, particulars, documentation and EIS mitigation measures submitted to the Planning Authority on the 18<sup>th</sup> of August 2010, as amended by the information submitted on the 16<sup>th</sup> of December 2010 and the 7<sup>th</sup> of March 2011, except where altered or amended by conditions in this permission.

**Reason:** To enable the Planning Authority to check the proposed development when completed, by reference to approved particulars.

- (a) No fallen animals, offal, bone and municipal waste shall be imported onto the site or used in the digestation process,
- (b) Imported materials shall be restricted to food processing dairy sludge, bellygrass, biofuel residue, mill waste and chicken litter as set out in the documentation submitted on the 16<sup>th</sup> of December 2010 (reference: further information response Item 1), and,
- (c) Any change in the type of waste and the maximum tonnage of each type of waste to be imported as set out in the EIS, will require a new planning permission.

3. Materials imported onto the site shall not exceed 23,000 tonnes per annum. A log of a deliveries to and materials exported from the site shall be maintained on site. The log shall be available for inspection by the Council at all times.
