To whom it may concern

We Peter and Diane O'Leary wish to make a submission regarding the KWD Recycling Ltd licence, registration no: W0217-02. As you may be aware from previous correspondences and telephone calls we have outstanding issues with the KWD recycling ltd.

This week we have discovered that Kerry County Council have sold their waste collection business to KWD, we also have been informed that KWD Ltd are now looking to increase their waste tonnage to 60,000 tonnes per annum.

The problems we have at the moment are;

Odour - We frequently have problems with nauseating odour coming from the KWD plant ( we have logged this with the EPA on different occasions).

Noise pollution - operating outside the licensing hours - HGVs entering the KWD plant at unacceptable hours e.g. 21:00hrs up to early hours of the morning, seven days a week. We can feel our house vibrating as they pass. The noise from the HGV's has often woken us and our children at night.

The damage caused to the Aughacureen road surface, by the volume and weight of HGV's going to the KWD plant - this road is not built to accommodate such traffic.

On occasion not being able to leave our property, as HGV's going to the KWD plant were parked outside our gate, as they have to que up on the road to wait to enter the plant.

The amount of traffic, and speed of the trucks is very dangerous in a residential area - we are especially worried for our children's safety.

We have an ongoing problem with infestation of flies in our home.

The KWD plant is operating from 06:00hrs - 02:00hrs - we can hear the recycling plant operating from our premises throughout these hours.

We are now very concerned what further implications this new contract that KWD has secured from Kerry County Council, will have on us, as we live in such close proximity to the plant.

If we are experiencing the above serious problems with KWD's existing license now, we most certainly will encounter more problems in the future, if the proposed licence is agreed to.
