In the application, Table B1 (i) has been completed for the 5 points.

WEP1 – Waste water treatment plant Final Discharge

SWMP1 - surface water

SWMP2 - surface water

SWMP4 - surface water

SWMP5 - surface water

There is not a separate table B.1 (ii) completed for each emission point.

The discharge for chlorides of 2500 exceeds the license limit of 250 & suspended solids discharge is 35 which exceeds the license limit of 15.

Section C

Table C.1 (i) Abatement/Treatment Control is completed for WEP 1 only & not the other 4 SWMP's.

Section D

Table D.1 (i) receiving water surface water quality has been included in the applicants application. Temperature, Electrical conductivity EC & Dissolved Oxygen are not listed. Other parameters Alkalinity-total (mg/l CaCO3), Chloride (mg/l Cl), Total Hardness (mg/l CaCO3) & True Colour have been included.

It does not state a distance to the nearest protected water source.
