

The following comments are in relation to the above application:

## Manure/Effluent

Section E.2. states all soiled water is diverted to the soiled water storage tanks, prior to its application to the applicant's landholding under the REPS scheme. Details of the lands available for land spreading have been provided, however, information is not provided on the composition/ nutrient content of this liquid waste or location of the spread lands in relation to water sources.

In relation to poultry litter, the EIS states it is sent for composting, and the application states it is landspread. The plot numbers listed in the letter, application Attachment No.H do not match the plot numbers listed on the maps of land for spreading the litter, application Attachment No.11. This requires clarification.

Poultry manure is stored in a covered area on site until removed by the farmer for landspreading. No further detail is provided on this storage structure. It should be ensured that this litter storage area is impermeable to rain/storm water to prevent run-off arising from it.

# Storm Water

Table E.2 (i) has not been fully completed.

#### Well

D.1. of the application states that water for stock and for washing is acquired from the local group water scheme. The EIS states that the on site deep bore well will also supply the new house. Potable water supplies must comply with quality parameters of Drinking Water Regulations (\$.1.278 of 2007). A groundwater protection plan should be drawn up to address but not be limited or overburden
-vulnerability of the borehole
-groundwater flows and gradient required the difference of protection and assessment current activities. to the following issues for wells:

- -current activities and past activities in the source protection zones

Section 1.3 of the application states that there has been no historical contamination of groundwater at this site. It is unclear if regular well water testing has been carried out to verify this. It is recommended to carry out regular testing of well water quality.

## Odour

It must be ensured all controls are put in place to prevent odour nuisance occurring. In relation to odour, Chapter 5 of EC IPPC- Reference Document on Best Available Techniques for Intensive Rearing of Poultry and Pigs, states "BAT is managing the landspreading of manure to reduce odour nuisance where neighbours are likely to be affected, by doing in particular all of the following:

- Spreading during the day when people are less likely to be at home and avoiding weekends and public holidays, and
- Paying attention to wind direction in relation to neighbouring houses.

# <u>Noise</u>

Section E.4 of the application on Noise Emissions has not listed particulars of the source, location, nature, and the period or periods during which the noise emissions are made or are to be made. B.A.T. specifies the standard noise emission limit values of 55(daytime) and 45(night time) dB(A) at any noise sensitive location.
