I've reviewed the sediment chemistry for the samples from Wicklow Harbour. The sediment is a mix of grain sizes with samples of up to 74% gravel, up to 92% sand and up to 51% silt. The chemistry of the sediment for most determinands tested was below the lower guidance level (according to the 2006 Guidelines for assessment of dredged material for disposal in Irish waters) and would thus be considered essentially clean.

Although concentrations of γ -HCH and HCB were below the limits of detection, the limits of detection were actually above the upper guidance levels. However, based on best professional addgement and past sediment chemistry, I'm satisfied that the sediment chemistry should not preclude the material being dumped at sea at a suitable site, in the event that no feasible alternative exists, and that χ -HCH and HCB concentrations are unlikely to cause a problem as a result of sea disposal.
