- (i) To increase the WEEE and battery intake capacity from a maximum of '10,000 tonnes per annum (1,000 tonnes of batteries and 9,000 for other permitted waste) to 15,000 tonnes per annum.
- (ii) The waste activities proposed will remain unchanged to those activities that are currently undertaken by The Recycling Village Limited.
