I refer to your notification with respect to supplementary information received by your authority on the 11<sup>th</sup> October 2012, please find chereunder nature conservation observations and recommendations of the Department of Arts Heritage and the Gaeltacht, for consideration by your Authority.

The marine mammal ecologist of the Department of Arts, Heritage and the Gaeltacht has reviewed the documentation sent on by the EPA and contends that the Risk Assessment undertaken in this instance is welcome and is roughly along the lines of the approach promoted in the Department's Guidance (Draft). Our marine mammal ecologist considers that its conclusion [i.e., Consent without Mitigation] is appropriate in this case given the general shallow riverine/estuarine location of the dredging proposed, our current knowledge of marine mammal occurrence in proximity to the Boyne river and estuary, and the absence of known sensitive areas for marine mammals in this inshore region.
