The following comments are in relation to the above application:

- 1. The HSE were not included in the scoping stage. It is recommended to consult with the HSE for such projects.
- 2. To reiterate what Farragh Proteins have stated in Section E.4 (ii) of the application, they must submit a nutrient management plan to the EPA, prior to any landspreading.

- 3. In relation to storage of sludge onsite, it should be considered if additional structural buildings will be required for such sludge storage. If so, this could be included in the current planning permission, and construction could be carried out while the main construction works are carried out, provided that planning permission is granted. This would avoid construction impacts occurring at another time.
- 4. Potable water is abstracted from the onsite borehole at the entrance to the site.

Potable water supplies must comply with quality parameters of Drinking Water Regulations (S.I.278 of 2007).

For wells a groundwater protection plan should be drawn up to address but not be limited to the following issues:

- -details of water source
- -details of bedrock
- -details of overburden
- -vulnerability of the borehole
- -groundwater flows and gradient
- -inner and outer zones of protection
- -details and assessment of landuse
- -current activities and past activities in the source protection zones

It is unclear if this well has any water treatment system applied to it.

It is recommended it carry out regular microbiological testing of well water quality.

5. In Section F.1 of the application details of any treatment, abatement and control systems for the surface water points SW2, SW3, SW4, SW5 have not been included.
