Re: Notification under Article 20 of the EPA (Licensing) Regulations 1994 to 2010

A Chara,

Further to your letter dated the 14th May 2013 regarding the IPPC No. P0948-01 for **Nigel Martin Ltd.**, Mullinacross, Smithboro, Co. Monaghan. On review of the EIS submitted the Environment Section, Monaghan County Council wish to make the following comments:

- Monaghan Co Council has concerns regarding the movement and tracking of manures from IPPC and large scale IAE enterprises to spread lands in this county due to the sensitive nature of many river and lake catchments and groundwater bodies.
- In the new County Development Plan 2013 – 2019 (available online at www.monaghan.ie), this council has developed policies in relation to activities that may affect water quality and in addition the plan contains a number of sensitive area maps (including water supply catchments etc). Monaghan County Council would request that any land spreading proposals from IAE/PPC facilities would take account of and be guided by the County Development Plan objectives, policies and maps. Activities should consult with this council in relation to land spreading in any sensitive areas. Monaghan County Council will make available guidelines and a sensitive area map to advisors/agents preparing Nutrient Management Plans/Land spreading proposals for IPPC facilities/IAE activities.
- All large scale activities should include, as a minimum suitably sized silt traps and preferably SUDS facilities for the disposal of storm water from hard surface areas to capture contaminants that may impact waters.
- The EIS states that 'The poultry manure/organic fertilizer is moved by conveyor directly into the manure store and/or waiting trailer unit, pending removal off-site by an experienced contractor, on behalf of the applicant'. No contractor details have been provided.
- No details of spreadlands where poultry manure will be spread are provided.
