Dear Ms. Kehoe,

I refer to your letter of the 5<sup>th</sup> July, 2013 to Michael McMahon, Director of Services (Planning) regarding the above, and to previous correspondence from Kerry County Council to the EPA of the 8<sup>th</sup> February, 2012.

We note that an Environmental Impact Statement (EIS) has been submitted by the applicant in this instant and, while Kerry County Council does not propose to comment in detail on the content of the EIS, we wish to point out the following:

As outlined previously, the activity in question has been the subject of a considerable number of complaints from local residents in the past. In particular, these complaints related to the control of odour emissions from the facility. Given the above, it is essential that the EIS should deal with this issue in detail and, in the event that odour issues are confirmed as being on-going, appropriate management measures should be proposed and implemented to address same.

Please note that this submission is made by both the Environment and Planning Departments, acting jointly on behalf of Kerry County Council.
