I refer to your letter to the 'Director of Services – Environment' received on 3rd September 2013.

We hereby respond as follows:

We have examined the details of the ELS submitted. We are satisfied that the E.I.S. complies in general with the Guidelines on Information to be Contained In Environmental Impact Statements (EPA, 2002) and also complies with the Advice Notes on Current Practice in the Preparation of Environmental Impact Statements (EPA, 2003).

However we consider that the applicant should be requested to provide copies of the Nutrient Management Plans, including the associated maps, for the proposed spread lands, for the poultry manure (approximately 415 tonnes) and the soiled water (approximately 110m3).

We would appreciate a notification of the proposed determination when issued in due course.
