## HSE EIS SUBMISSION REPORT

## **Environmental Health Service Consultation Report**

This report only comments on Environmental Health (EH) Impacts of the proposed development as outlined in this EIS and the adequacy of the EIS from an EH viewpoint.

The assessment consisted of a study of documentation on the EPA website, EPA guidance documents and a visit to the site of the activity at Barnagurry, Kiltimagh, County Mayo. No additional measurements/investigations were undertaken and comments are limited to matters relevant to the HSE.

We have made observations and submissions on the following specific EH areas:

# Ground Water Quality / On site borehole

The EIS informs that a water sample from the on-site bored well was delivered to Alpha Analytical Services Ltd. (Laboratory) for testing on 17<sup>th</sup> August 2012 and analysed for microbiological parameters. While results of analysis of this sample indicates the water to be free from microbiological contamination at that time, ongoing periodic monitoring would be required to determine if this is representative of the general quality of the water. Sampling for relevant chemical parameters would also be advisable to ensure suitability for its use. A new wellhouse has recently been constructed.

#### **Pest Control**

Rodent baiting points are in evidence at the site positioned at intervals around the 2 houses. Evidence of rodent activity was noted to the rear of house number 2 between bait points 13 & 14. A large earth bank is present running along house number 2, I assume created when soil was stripped off the site to facilitate construction of the 2 houses. This bank is not maintained and presents harbourage for rodents, contrary to the claim in the EIS that "Weed control (by herbicide control and cutting of the vegetation) is carried out around the site as required to reduce any cover for pests and maintain good housekeeping."

Intensive agriculture presents a significant attraction to pests and every effort must be made to ensure the activity does not impair or interfere with amenities or the environment at the installation or beyond the site boundaries at neighbouring lands/properties.

## Waste Disposal

Veterinary waste, described in the EIS as comprising of "Bottles: Plastic and Glass and plastic and paper material is disposed of by McGrath Waste." Such containers are "thoroughly washed out with the washings stored in the waste water storage tank" prior to being applied to the applicants' land. While this may be acceptable for detergents and feed containers, confirmation should be sought from the applicant as to the requirements for the correct disposal of true veterinary waste such as antibiotics and vaccines as are occasionally required to be administered. Advice from Teagasc states that disposal should be as per manufacturers' instructions, that items such as animal remedies/medicines should not be disposed of in domestic rubbish, down drains or watercourses or into household sewage and that use should be made of any schemes whereby such unused chemicals/medicines are returned to the supplying veterinary surgeon/pharmacist for correct disposal.
