I have been asked by An Bord Pleanála to refer to your letter dated 16th May 2014 in relation to an application for a waste licence or a review of a waste licence pursuant to section 173A(4) of the Planning and Development Act 2000, as inserted by Article 10 of the European Union (Environmental Impact Assessment) (Waste) Regulations 2012.

In respect of the Environmental Protection Agency's request for observations and having regard to the specific queries raised in your letter, the Board would wish to commentate ollows:

- Having carried out an initial inspection of the documents on the Agency's website the Board considers that
  the activity subject to the current licence appliant on would appear to be the same as that which was
  granted, subject to conditions, by the Board.
- The decision was made by the Board after the carrying out of an environmental impact assessment and following an oral hearing into the case which commenced on 22nd March 2011 and concluded on 30th March 2011.
- The Board can confirm that the EIS and all appendices associated with the EIS lodged with the application on 10/12/2010 is the same as that submitted to the EPA under W0129-03 on the 17/12/2010. The Board in its decision dated 16/06/2011 (ref 06F.PA0018) granted planning permission for the Integrated Waste Management Facility subject to 22 conditions. The Agency's attention is brought to the Inspector's Report prepared in relation to 06F.PA0018 which evaluated the contents of the EIS throughout the course of the planning assessment (pages 30-96 of report) and also summarized the content of the EIS (pages 107 to 138 of report). Full details of the Inspector's Report and the Board's Decision is available on the Boards website www.pleanala.ie. The Agency's attention is also brought to the Board's final decision as set out in the Direction and Order with particular attention to the Reasons and Considerations and Conditions imposed on the grant of permission.
