Re: Dumping at Sea Permit application from Donegal County Council in relation to Buncrana Harbour, Co. Donegal ((S0011-02)

Dear Tara

Donegal County Council has made an application for a 3-year Dumping at Sea Permit to facilitate the dredging of 15,000 – 20,000 tonnes annually of sediments (mainly sandy at Buncrana Harbour in Co. Donegal. It is intended that Plough Dredging will be used. The area to be dredged is shown in Map 1, dated March 2014, in Appendix D.2(ii) of the application documents.

Dredging of similar amount of material has been carried out, under Permit, on an annual basis in this area since 1999 with the most recent dredging being carried out in uly 2013.

The material to be dredged is mainly sand chemical analysis of the samples of the material shows that the levels of contaminants are low and the material can be considered as being clean and suitable for unconfined disposal at sea.

There are a number of licenced aquaculture sites in Lough Swilly. The nearest licenced aquaculture site is located circa 2.4Km to the west of the area where the plough dredging is proposed.

Given the physical and chemical characteristics of the material, the location of the plough dredging area and the relatively small volumes of material involved the Marine Institute is of the view that the activity will not have a significant adverse impact on aquaculture or the marine environment in the area and has no objections to a Permit being issued.
