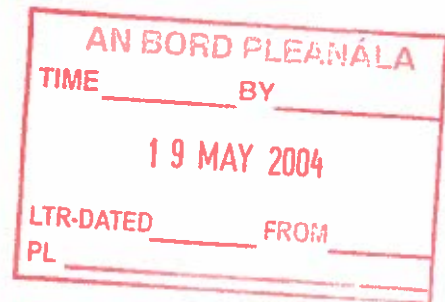
I submit that you have not supplied the information I requested on 5 Jan 2004, to which I still have not received an acknowledgment.
