
I refer to your letters of the 13<sup>th</sup> June and 14<sup>th</sup> June, 2104 in connection with the above.

Cork County Council has no objection in principle to the granting of a waste licence to Mallow Contracts Ltd however the following comments are made:

- Planning permission 06/10406 was granted for the infilling of existing low lying lands with topsoil, subsoil, rock fill and minor quantities of construction and demolition material at Lissard & Ballyhillogue, Mourneabbey, Cork on the 13/3/2007 for a period of 5 years. The planning application file can be inspected at the Planning Department, County Hall, Cork.
- 2. Waste Facility Permit CK(N) 277/05 permitted the infilling of existing low lying lands with soil and stone as well as construction and demolition waste at Lissard & Ballyhillogue, Mourneabbey, Cork. The section of the permit entitled 'Activities Permitted' lists the activities permitted under the aforementioned permit is 2000.

Permitted Waste Recovery Activity in accordance with Part 1 of the First Schedule of the Waste Management (Permit) Regulations, 1998:

Activity 5: The recovery of waste (other than hazardous waste) at a facility (other than a facility for the composting of waste where the amount of compost and waste held at the facility exceeds 1000 cubic metres at any time).

Permitted Waste Recovery Activity, in accordance with the Fourth Schedule of the Waste Management Act, 1996 to 2005:

- Class 2: Recycling or reclamation of organic substances which are not used as solvents (including composting and other biological processes).
- Class 4: Recycling or reclamation of other inorganic materials
- Class 10: The treatment of any waste on land with a consequential benefit for an agricultural activity or ecological system.
- 3. Cork County Council notes that under the Section of the EIS entitled 'Purpose of the Development' it is stated that:

....Since Cork Co Council granted the permit, the EPA has been requested to include a number of non hazardous specific wastes as defined under the European Waste Catalogue. The waste categories include

...17 03 01\*- bituminous mixtures containing coal tar and

19 12 12 - (other wastes including mixtures of materials) from mechanical treatment of wastes other than those mentioned in 19 12 11....

Cork County Council is not in favour of the acceptance of hazardous waste in a soil and stone recovery facility as the acceptance of such waste in an unlined site might be problematic.

Cork County Council is not in favour of the recovery of a waste with an EWC 19 12 12 (other wastes including mixtures of materials) from mechanical treatment of wastes other than those mentioned in 19 12 11 in soil and stone recovery sites as it is not clear that such a waste would be a useful material for site engineering.

- 4. In the event that waste licence application W0266-01 is granted, the Council requests that a condition in relation to traffic movements to and from the site be attached to the waste licence.
- 5. Prior to a decision being made on waste licence application W0266-01 the Council recommends that the applicant be requested to submit a topographical survey for the site to the Agency in light of the transition from the site being authorized by way of a waste facility permit to it being now the subject of a waste licence application.
