We refer to your correspondence dated 19<sup>th</sup> December 2014 in relation to the above matter and wish to apologise for the delay in responding.

- 1. We can confirm that the EIS, submitted as part of the licence application, is associated with two planning permissions: Plan. Reg. No's.: 13/50220 and 13/50221. - 2. We can confirm the following developments permitted were permitted under Plan. Reg. No's.: 13/50220 and 13/50221:

Plan. Reg. No.: 13/50220 – Planning permission was granted on 16/09/2013 for the construction of 1. (a) 9 no. pig weaner/finisher houses, (b) extensions to 1 no. existing pig finisher house, (c) extension to 1 no. existing pig house to comprise a feed storage area, (d) 1 no. feed preparation store; 2 relocation 1 no. grain store (previously approved under file no. 08/40082); and, 3. decommission 3 no. existing pig houses, and 1 no. overground manure storage tank (previously approved under file no. 08/40026); 4. together with all ancillary structures (to include meal storage bins, rainwater harvesting tank, storage tanks) and all associated site works (to include upgraded site entrance (s)) arising from the above proposed development.

No.: 13/50221 - Planning permission was granted on 22/04/14 for the construction of (a) 1 no. pig farrowing house, (b) extensions to 1 no. previously approved loose dry sow house and 1 no. existing gilt house, (c) together with all ancillary structures (to include meal storage bins and w.c.) all associated site works (to include, wastewater treatment system and percolation area).

The terms of the aforementioned planning permissions did not specify or place a restriction on the amount of production pigs or sows at the development locations.
