Further to your letter of March 31<sup>st</sup> 2015, with regard to the above, the Planning Authority makes the following observations.

A number of concerns relating to site improvements to minimise risk to waters were dealt with by AI and subsequent submissions. In relation to off site disposal or recovery of manure applicant EIS states that recovery will take place via compost yards and DAFM approved contractors.

The EIS does not indicate that any manure will be land spread in Co Monaghan. Due to density of poultry units, land type (mainly grassland) and potential for cumulative effects disposal via an approved recovery facility is acceptable from a water management view point.

Provided the EPA licence does not permit land spreading of manure in Co Monaghan and development is built in accordance with plans & AI submitted – risks to waters should be minimised.
