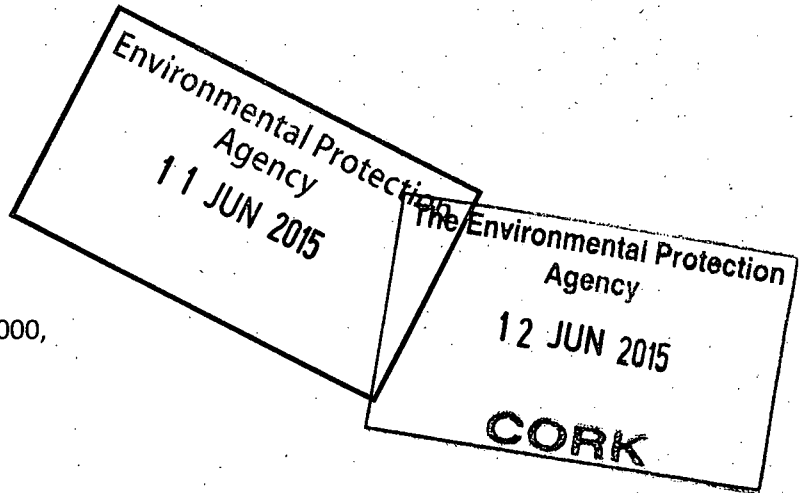

A Chara,

Monaghan Planning Authority makes the following recommendations to make with regard to the application to review of the above mentioned:

- All licensed facilities of off-site disposal of organic fertilisers and their agents should take account of sensitive areas identified in the County Development Plan 2013-2019. The licensee should demonstrate that the County Development Plan objectives and policies for protection of waters are integrated into site management, landbank selection and nutrient management planning (including phosphorous application rates). The proposed use of landbanks by licensee and their agents in the catchment of water supply sources should seek approval in writing from the local authority.
- A fully traceable manure movement system for offsite movement of manures is provided by the licensee.
- Soiled water facilities and management practices should be adequate to prevent discharge of contaminated waters to any watercourse.
