**RE: DaS Licence Application S0024-01 – Dublin Port Company**

A chara,

I write to make the following observations in relation to the above application:

**1. Location of Disposal Site**

The location of the proposed disposal site needs to be carefully assessed to ensure that local tidal flows do not result in the disposed material being carried back in to the inner Bay and deposited on near the shoreline. I believe there may be merit in moving the disposal site out further to deeper water.

**2. Processing of Silt Contaminants**

Any dredged material that has elevated levels of toxicity should be isolated, treated and disposed of separately; this will require the implementation of a continuous sampling & testing programme.

Please note that I am broadly supportive of Dublin Port's plans as it follows through on their Master Plan commitment to make maximum use of existing facilities.

I would appreciate it if the above would be considered in detail when assessing this application and I look forward to hearing from you.
