Proposed Development: Applicant is seeking an Industrial Emissions Licence for its existing baled waste storage facility at Lockington's Yard, Quay Street, Dundalk, Co. Louth.

General Introduction:

This report only comments on Environmental Health (EH) impacts of the proposed development as outlined in this EIS and the adequacy of the EIS from an EH viewpoint. We reviewed all areas specific to EH such as water, noise, emissions to air including dust and odour etc. and have made observations and submissions on odour and pest control.

The facility currently operates under a Waste Permit issued by Louth County Council. It stores baled waste at the site pending shipment for use as fuel overseas to energy plants and cement kilns. The waste materials are baled prior to arrival in multiple layers of polythene sheeting. At the time of our visit to the facility it appeared to be well maintained and tidy and there was no detectable offensive odour outside the perimeter of the waste facility site.

There have been no complaints received by this department to date and after contacting Louth County Council in February 2015, they advised that they have received few complaints.

Observations:

Odour

The main complaint on record for this facility was an odour complaint as a result of very dry weather and the fact that the ship was unable to birth at the port. The incident was addressed and the company have developed a policy if such an event should occur in the future. They have referred to this in the EIS. There was no issue with odour during our site visit as mentioned above.

Pest Control

We were advised during our site visit that good housekeeping is practiced on site and there was no evidence of rodents, flies or birds at the time of our visit.

- We were informed that an ad hoc rodent control takes place on site, whereby bait is placed on site at various locations and is monitored. There was no reference to how pests are monitored and controlled in the EIS or Waste Permit Application.
- I received an 'Environmental Nuisance Control Programme' 'Procedure No. 4' 'Date of Issue 11/9/2015' from the consultants O'Callaghan Moran & Associates on my request, which describes the environmental nuisance inspection control measures for the Company. It details how they do a daily inspection for vermin and it vermin are identified, the Site Manager will arrange for a specialist pest control company (Dundalk Pest Control) to visit the site and take appropriate action. However, there is no mention of monitoring bait points in 'Procedure No. 4'.

Conclusions:

It is the opinion of the Environmental Health Department that the EIS submitted for the Application of an Industrial Emissions Licence addresses EH concerns over water, noise, emissions to air including dust and odour however, it does not fully address the potential public health nuisance of pest control. They need to detail 'Procedure No. 4' in their EIS.
