No consultation reports have been received from the above departments at the time of issue of this correspondence.

This IPPC Licence was assessed with respect to Environmental Health (EH) Impacts of the activity as outlined in the application. The assessment consisted of a study of the application and associated correspondence and documentation on the EPA website.

A site visit was conducted on 29th October 2015.

No additional measurements / investigations were undertaken.

No complaints in relation to the past or present operations at this facility have been received by this department regarding this operation.

During my site visit it was noted that odours at the site, particularly at the Milltown side of the operation were evident. This was highlighted to the applicant who informed me that this was previously more pronounced but as a result of upgrades to the facility it has been reduced and will be further reduced as a result further housing upgrades. Odour levels from the facility must be such so as not to cause undue nuisance or annoyance to sensitive receptors in the area or will not interfere with the amenity outside the boundary of the site.

Provided that the measures as outlined in the support documentation submitted with this licence application (EIS) which I accept in good faith as true and accurate are fully adhered to and the odour situation as previously mentioned is closely monitored and attended to as necessary the Environmental Health Department of the HSE South (Kerry) would not have any general concerns with this licence application which is currently being considered by the EPA.
