I refer to the above planning application for an EPA licence at Nauntinane Milltown Co Kerry and I wish to lodge an objection to this business as it is presently run. The Piggery is located four telephone poles from my home and directly in line with my front door. Both buildings are located in a type of valley enclosed by the high ground of Ballyvirane and Nauntinane hills. Over the past few years the smell from the piggery has become progressively worse. It travels across the valley and contaminates the air rendering it almost unbreathable.

As I live alone, am elderly, in receipt of disability I try and keep active with walking on the road near my home. Normally I would take a stroll morning and evening. I look forward to the exercise but on several days of the week when I open my door I have to bang it closed and remain indoors such is the terrible odour. Even when walking neighbours don't want to stop their cars for a chat owing to the smell. On several occasions drivers have stopped looking for directions. When they pull down the windows their first question is; what's the smell?

On the 4 November I was standing at Nauntinane Hill and saw a lorry leave the piggery. It passed by and headed towards Milltown. There was a low butted trailer on back with dead pigs heaped on the trailer, clearly visible. I nearly got sick. The smell was atrocious.

In sincerely hope that proper controls to prevent this most objectionable activity are introduced and If you need any more information I will be glad to provide same.
