larnród Éireann are in receipt of your correspondence dated the 27/01/2016 regarding the EPA's review of the Industrial Licence held by Enva Ireland Ltd in relation to their facility located at Clonminam Industrial Estate, Portlaoise, County Laois.

Since 2007 larnród Éireann have engaged with ENVA Ireland on several occasions in relation to the migration of odours and dust onto the larnród Éireann Portlaoise Rail & Sleeper Depot located adjacent to the Enva Plant. Iarnród Éireann have previously communicated to management at ENVA Ireland Ltd that larnród Eireann staff working at the Depot are experiencing a reduced quality of workplace well being and general annoyance as a result of nuisance odours which are migrating from the ENVA plant onto our property (*REF: attached letter larnród Éireann – ENVA 10/10/14*).

larnród Éireann have also previously made it known to the management of ENVA Ireland that the open shed area at the northern end of their property where soil remediation takes place has on several occasions generated significant amounts of dust during dry weather conditions which has settled on the depot's specialised plant and machinery resulting in increased machinery maintenance and potentially reducing the equipment's lifespan.

In a letter dated 31st October 2014, ENVA Ireland proposed to enclose the processing area of their soil remediation building (*REF: attached Letter ENVA - larnród Éireann 31/10/14 and 09/02/16*); and whilst I understand that planning permission was granted for this during 2015, no work on this has taken place to date.

In the same letters ENVA Ireland outlined their intention to trial an odour abatement system on their site in an effort to reduce the nuisance odour emanating from their facility. It should be noted that nuisance odours are still being reported by larnród Éireann staff at Portlaoise on a regular basis.

Therefore, it is imperative that larnród Éireann's submissions outlined below are incorporated into any future industrial licence issued to ENVA Ireland for their facility at Clonminam, Portlaoise:

- Item 1: The processing area of the soil remediation building at the ENVA plant at Clonminam, Portlaoise is completely enclosed as outlined in letters from ENVA to larnród Éireann dated 31/10/14 and 09/02/16, within 3 – 6 months.
- Item 2: The implementation of an effective odour abatement system at the ENVA plant at Clonminam, as outlined in letters from ENVA to larnród Éireann dated 31/10/14 and 09/02/16, within 3 – 6 months.
- Item 3: That measures are put in place to ensure emissions from the ENVA plant at Clonminam do not exceed any istatutory limits regarding ambient air quality at any time.
- Item 4: That no harmful emissions are discharged from the ENVA plant at Clonminam into the surrounding areas at any time.
- Item 5: The continuance of any licence is dependent upon the success of the control measures outlined in Items 1, 2, 3 and 4.

Iarnród Éireann would be interested to understand how the implementation of these and other control measures will in the future be monitored to ensure compliance is maintained in accordance with the requirements of the appropriate regulatory authorities.

larnród Éireann would ask that the licence outlines provisions for accountability for ENVA in relation to dealing with environmental complaints in a timely and efficient manner.

Re: Migration of dust and nuisance odours onto IE property, Old Knockmay Rd Portlaosie.

To Ann Fitzpatrick

As you have been made aware of previously, over the past humber of years there have been ongoing EHS issues which have occurred at the larnród Eireann Sieeper Depot Plant on the Old Knockmay Rd as a result of migration of dust and nuisance occurs emanating from the ENVA waste facility located at the Clominam Industrial Estate Portlaoise.

In the past number of months, several documented formal complaints have been received by the Sleeper depot's Safety Executive from members of IE staff regarding dust and nuisance odours. In response to this issue, IE management at the sleeper depot site are now maintaining an air quality log sheet in order to record instances of dust and odour issues.

In previous meetings with your organisation, IE have been assured by ENVA that the parameters for emissions which they are licensed to omit have not exceeded their ambient air or OELV limits, however this does not negate the fact that our staff are experiencing a reduced quality of workplace wellbeing and general annoyance as a result of nuisance odours which are migrating from the ENVA plant onto our property. IE also have plant and machinery which is stationed adjacent to the roofed soil remediation area of the Enva waste plant which are subjected to dust settling on the machines from ENVA's soil remediation area. This issue has the potential to result in increased machine maintenance costs which IE are not willing to incur as a result of ENVA's avoidance to implement effective mitigation measures in respect of dust migration onto our site at this particular area.

IE have a duty of care towards providing a safe and comfortable working environment for its employees and we are compelled to write formally to you now and ask that ENVA invest in appropriate and effective long term mitigation measures at their waste facility in Portlaoise in order to prevent dust migration and nuisance odours effecting the immediate area of the facility as outlined in section 7.2 of the relevant EPA Waste License Register No 184-1.

"7.2 The licensee shall ensure that dust, noise and odours do not give rise to nuisance at the facility or a state immediate area of the facility. Any method used by the licensee to control any such nuisance shall and not cause environmental pollution or contravene any national statutory protection granted in respect of the protected species or cause significant interference with amenities or the environment beyond the site of boundary."

I would ask that management at ENVA Pertiaoise respond within 21 days of receipt of this letter with intended proposals for appropriate and effective mitigation measures to be implemented on your site to prevent migration of odours and dust onto our property.

In the meantime we will continue to record dust and odour issues in our internal air quality log and officially record formal health and safety complaints within our safety management system as evidence of the ongoing EHS issues caused by ENVA's activities on IE property at Old Knockmay Rd Portlaolse.

Dear Mr Ruane,

I refer to your letter regarding the 'Migration of dust and nuisance odours' onto the Irish Rall site in Portiaoise. I can reassure you that we do take any such concerns seriously and endeavour to be a good and responsible neighbour. As you have correctly noted Enva does indeed carry out regular occupational and air quality monitoring at our site here in Portiaoise and such monitoring has not indicated there to be any significant issue in relation to dust or indeed odours. However we do accept that there may be occasions when a temporary nuisance issue with regard to odour or dust can arise from our site. As such we are proposing to react to the concerns raised and implement the necessary measures to prevent the occurrence of dust or odour issues from our site.

Since receipt of your letter we have engaged with a UK based company (APPS UK Ltd.) who specialise in the suppression of both dust and odours. A technical representative from the company has also visited our site to understand and assess the issues that may present in relation to the potential generation of dust and odour. Subsequent to the site visit the company have presented some preliminary proposals for the provision of dust & odour abatement reagents and application equipment which need further evaluation. In addition we are also assessing if it is possible to modify our existing dust suppression vehicle so that it could be used to apply the products being recommended by APPS UK.

During the winter months it is less likely that any significant dust issue will arise due to the wetter weather. As such the winter months may provide an opportunity to refine the necessary design, carry out any trials if necessary and then purchase the necessary of equipment before the summer when dust generation is more likely. We have already obtained an odour abatement reagent from APPS UK and have on loan a delivery system for trialling at our site.

Re: Dust & Odour Nuisance

Dear Mr Ruane,

Further to my letter of October 2014 I would like to update you on the progress we have made in respect of the issues you had raised to me regarding potential dust and odour.

I would like to reassure you that we are committed to applying the highest possible standards to the operation of our Portlaoise facility. Enva has been an integral part of the Portlaoise community for over 30 years and is a responsible company, processing the majority of waste oils collected in Ireland into high quality fuel products.

In relation to the potential for dust migration from the Enva site, subsequent to renting a mobile dust suppression unit on a trial basis from the specialist company (APPS UK) we have since proceeded to purchase the unit for use on our site as necessary. Furthermore in 2015 we obtained planning permission to better enclose the soil remediation area and works have already commenced to complete these works (with an expected completion date of the 4^{th} of March 2016).

Enva is not the only source of odours in the local area, however, Enva does accept that there is the potential for odours to be generated on occasion due to its processing of waste oils. In particular, the final stage of the production process where we remove the remaining excess water from the oil using heat has been identified as having a significant potential to create odours in the local area. This part of the process has now been suspended.

However, other than odours, Enva is not aware of any air quality monitoring results that have shown any air quality parameter to be exceeding its relevant guideline value. The EPA has conducted air quality monitoring in the vicinity of the plant, the results of which have shown there not to be any exceedances of guideline values.

In response to the matter Enva has submitted a proposal to the EPA to install an odour abatement system (to capture emissions from the oil drying process) at a cost of approximately €1 million. Enva is engaged with the EPA so as to obtain approval to the term.

We are fully committed to making sure that we at Enva Ireland can fulfil an important role in safeguarding the environment without impacting on the welfare of our neighbours. The EPA has initiated a review of our licence and we intend to work closely with them in completing this process. In the interim, the company is implementing a range of measures to ensure that there are no nuisance odours created by the continued operation of the facility.

I hope this clarifies the matter sufficiently for you and we would welcome the opportunity to meet with you regarding your concern, alternatively please do not hesitate to contact myself or Gareth Kelly (C.O.O.) should you wish to clarify or discuss the matter further.
