I refer to your correspondence dated 21<sup>st</sup> July 2016 in respect of the above and wish to advise as follows:

The planning histories relating to the site is as follows:

**07/1452:** Erect a poultry house and poultry litter store. An Environmental Impact Statement accompanies this planning application.

**14/372:** Erect a new poultry unit adjacent to existing poultry houses and insert a new holding tank. This application relates to a development that is for the purpose of an activity requiring a licence under part IV of the Environmental Protection Agency Acts 1994-2013. An Environmental Impact Statement (EIS) accompanies this planning application.

**16/207:** Permission to construct 2 no. poultry houses and an extension to 1 no manure store together with all ancillary structures (to include soiled water tanks, meal bins etc.) and site works associated with the above development on an existing poultry farm. An Environmental Impact Statement (EIS) accompanies this planning application.

The Planning Authority has no further comment to make with respect to the licence application and EIS submitted in accordance with the provisions of Section 87(1D)(a) of the EPA Acts (as amended).
