## **HSE EH Submission Report**

(As a Statutory Consultee (Planning and Development Acts 2001, & Regs made thereunder)

### Assessment of the License Application

A review of the application and planning permission was undertaken. The environmental license application is for a new wastewater treatment plant on a green field site in Courtmacsherry that would serve both Timoleague and Courtmacsherry, it would cater for a population estimate of 2,500 and tourists have been factored into this estimate.

Planning permission has been sought for this project by Irish water ref no: 16/00400 and it was granted on the 19<sup>th</sup> of August 2016 subject to a number of conditions which include:

- 1. No polluting material to enter any watercourse
- All waste to be recycled and/or removed safely to the approved facility
- 3. Hazardous or contaminated waste to be removed safely
- 4. Noise levels to be abided
- 5. No odour/dust
- 6. A Construction and Environmental Management Plan
- 7. Traffic Management
- 8. Soak ways for surface water on roads

### 9. Lighting

- 10. Protection from flooding
- 11. Existing septic tank to be decommissioned properly
- 12. Service cables to be run underground

The following points were noted from the environmental licence application:

1. No discharges to groundwater take place in the agglomeration.

2. The receiving waters are not designated as bathing, sensitive or shellfish waters.

3. No water abstraction points/drinking water abstraction points exist downstream of any discharge.

#### Recommendations

- Further clarification should be sought on what Interim measures are proposed to be used for the treatment of waste between the decommissioning of the original septic tank in Courtmacsherry and the new waste water treatment plant being fully functional.
- All proposed mitigation measures to reduce potential odour emissions should be fully adopted.
- A strict monitoring regime should be put in place and all discharges from the facility to water must be monitored and records maintained and available for inspection to the Agency. We are seeking clarity of the sampling methodology, frequency and proposed analysis required.
- The IPPC Licence should require a full performance system of the proposed waste water treatment plant including plant and operation, emergency procedures, and procedures to follow in the event of a failure to meet treated effluent standard.
- Alarm devices in the treatment plant and pumping facilities are to be calibrated and maintained in line with manufacturing guidelines.
- A pest control procedure and waste management plan should be approved by the official agency and form part of conditions for which the facility can operate. Rodenticides and/or insecticides if employed must be properly managed.
