16/125: Permission to consist of the construction of 1 no. poultry house, 1 no. meal silo, all associated concrete aprons, wash water collection precast tank plus all ancillary site works related to the proposed building works, site entrance and site boundaries.

The proposed development will afford for 55,000 broiler places.
