In response to the letter dated 25/10/2016 in relation to submission to the agency of EIS on 21/10/2016..

Throughout the EIS references are made to the European Union (Good Agricultural Practice for Protection of Waters) Regulations, 2006 and 2010. No reference has been made in relation to S.1 No. 31 of 2014 which is most relevant in relation to changes made Under PART 3, *in particular duties of occupier in relation to nutrient management*, and PART 5, *keeping of records by occupier*.

The dates referenced for landspreading, refer to Co. Meath. The maximum fertilisation rate for Nitrogen is 170kg/HA, not in fact 250 KgN/Ha. This is the upper derogation limit and applications for increased rates of fertilisation are determined by The Department of Agriculture, Food & the Marine.

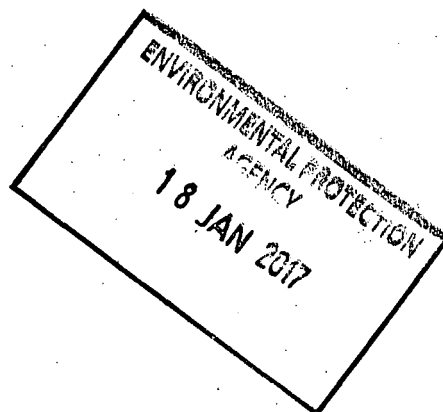
The final destination of manure from this facility is unclear, whether export by a registered haulier, land spread by receiving farmers or on the applicants own lands in accordance with a Nutrient Management Plan.

If this EIS were part of an application to Monaghan County Council for a poultry Unit, under the threshold for licensing, refusal would be recommended.
