The planning histories relating to the site namely P96/336 and P13/282 are noted.

P96/336 - Permission to erect 2 poultry units and effluent tanks subject to a number of conditions.

P13/282 - Permission to erect a poultry unit, underground washings storage, mealbin and all ancillary works subject to a number of conditions.
