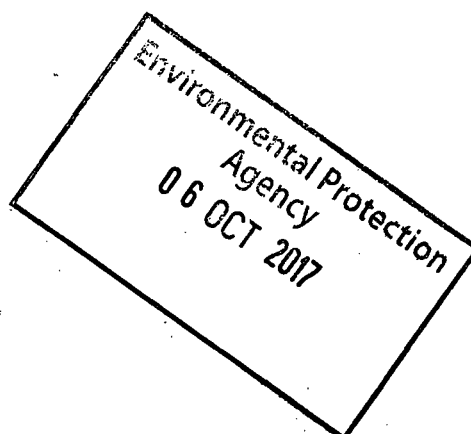

The planning histories relating to the site are as follows:

**07/2138:** erect two no. poultry houses. An Environmental Impact Statement is also submitted to the Planning Authority with the application, and this Statement will be available for inspection or purchase at a fee not exceeding the reasonable cost of making a copy, during the office hours of Monaghan Council.

**13/9006:** Extension of duration granted – expiry date 17<sup>th</sup> June 2018 erect two no. poultry houses. An Environmental Impact Statement is also submitted to the Planning Authority with the application, and this Statement will be available for inspection or purchase at a fee not exceeding the reasonable cost of making a copy, during the office hours of Monaghan Council.


