

I have been asked by An Bord Pleanála to refer to the above-mentioned application and to your letter dated 21st September 2017 requesting comments in relation to the above-mentioned application for an Industrial Emissions licence pursuant to the provisions of section 87 of the Environmental Protection Agency Act 1992, as inserted by Article 5 of the European Union (Environmental Impact Assessment) (Integrated Pollution Prevention and Control) Regulations 2012. The Board's observations in relation to the above-mentioned application are as follows:

- (i) There is a live planning application under consideration by An Bord Pleanála (Application Ref. 09.JA0041) which relates to this site. There is also a live compulsory purchase order application (Ref. 09.CH3351) which relates to this site.
- (ii) The Board is aware that the proposed development is a licensable activity.
- (iii) The information relating to the EIAR on the EPA's website is the same information as in the EIS submitted to An Bord Pleanála.

  - Kildare County Council Ref 03/2355; An Bord Pleanála Ref PL09.206726 for further development/extension of site.

In accordance with Section 171A and Section 172 of the Planning and Development Act, 2010, the Board will carry out an Environmental Impact Assessment in respect of the proposed development.

In accordance with Section 177U and/or Section 177V of the Planning and Development Act, 2010, the Board will carry out screening for Appropriate Assessment and/or Appropriate Assessment as required.
